
ORDER





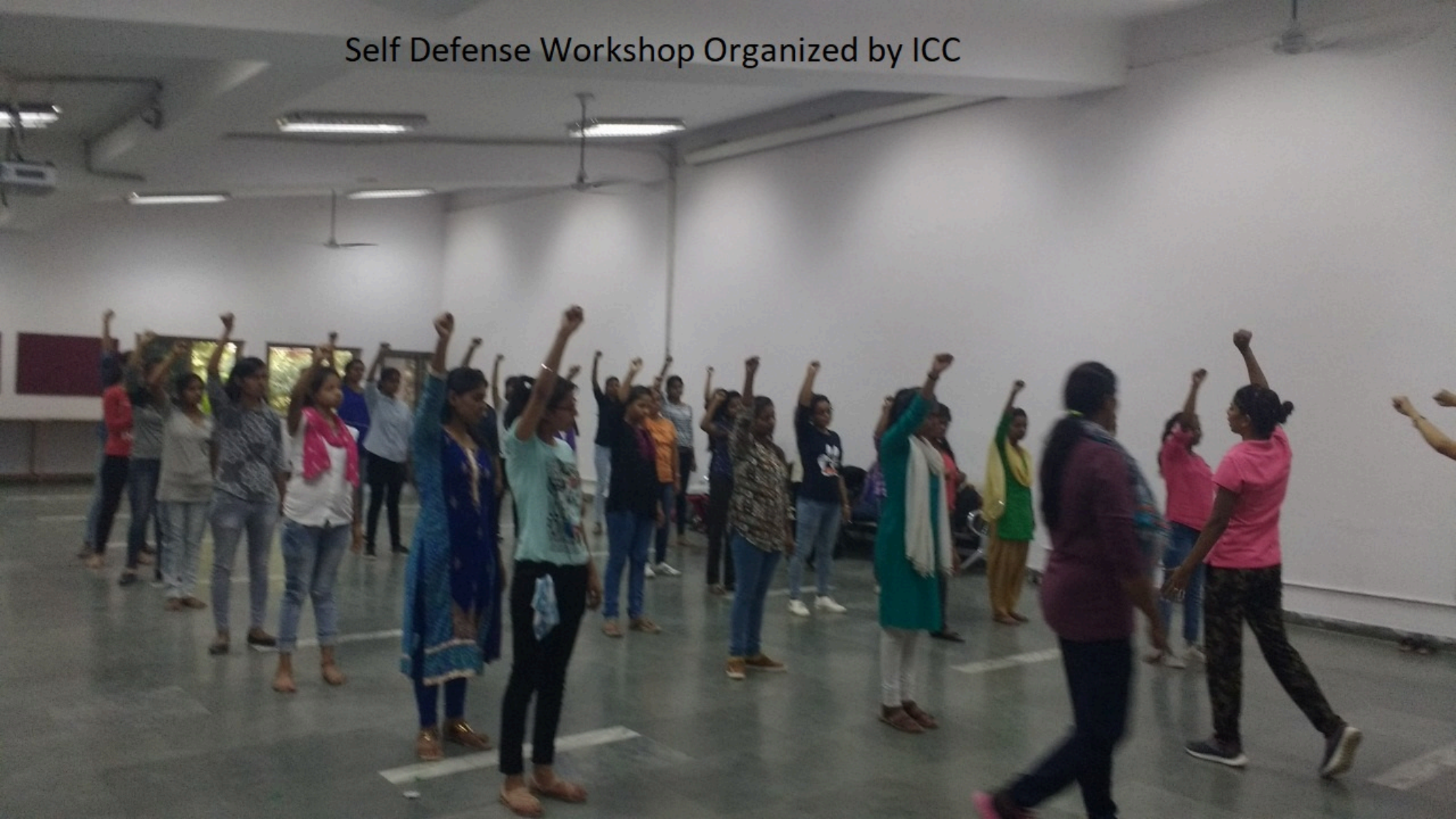
