SERVICE CONTRACT

ALS WELLNESS NETWORK PVT LTD., (ALS), with a brand name "zyego", having registered office at J 1931, CHITTARANJAN PARK, New Delhi 110019, India. ALS is services to member institutions.

AND

Maharaja Agrasen College, University of Delhi, (referred in this document as "MAC"), having its principal premises at Vasundhara Enclave, Delhi 11009 which expression shall, unless be repugnant to the context and meaning hereof mean and include its successors and permitted assigns and such other subsidiaries, affiliates, or entities controlled by the company), as the party of the other part.

TERMS AND CONDITIONS

1. Appointment

ALS is hereby appointed as the wellness consultant for the staff and students of MAC. This appointment is valid for a year and shall be effective from October, 2018.

ALS will carry out all activities related to emotional wellness for the staff and students at MAC. It shall handle online counselling, activities and workshops as per an agreed schedule and format in discussion with the college administration.

2. Scope of Services:

The following services are to be rendered to MAC. The Scope of services and prices may vary from time to time depending upon feasibility and requirements from MAC.

- a) Counselling of its members, using the app
- b) Face to face counselling of its members, at college or at zyego office
- c) Group therapy sessions, both face to face and via invite only confidential chatrooms
- d) Personality assessments using psychometric methods
- e) Organizing workshops on relevant issues
- f) Organize events which foster wellness, cohesion and a healthy work environment

3. Schedule of charges

- a) MAC shall pay ALS @ Rs 10,000 per workshop for the semester July to December 2018, and January to May, 2019, to conduct a minimum of 8 workshops for students, faculty and non-teaching staff. Additional workshops, MAC at the same rate per workshop.
- All students of MAC would be provided free 30min of therapy time at the time of registration with the app.
- c) The following activities will incur additional charges:
 - Special workshops for faculty
 - Therapy sessions via the app over the free minutes.
 - Face to face sessions in person with the therapist
 - Select indoor and outdoor activities
 - Personality assessments using psychometric methods

If the college subscribes to any of the above services, additional charges will be discussed and agreed upon and appended to this agreement.

- d) Workshop charges payable will be cleared by the end of each workshop and before the next workshop as per the agreed time plan.
- e) The above cost and professional fees are exclusive of applicable state and federal taxes

4. General terms and Conditions

- a. Terms of Use This contract is also bound by the general terms and conditions of use of ALS as a consultant. A copy of the same is enclosed in annexure
- b. Confidentiality- It is envisaged that the Parties (MAC and ALS) or any members of their respective organizations or any of their respective Agents may from time to time disclose Confidential Information relating to its current or proposed business to each other. In consideration of such Confidential Information being made available to both parties, ALS and MAC agree that land disclosure or dealings between the Parties will be subject to the terms any disclosure or dealings between the Parties will treat and keep all and conditions of this Agreement. Both Parties will treat and keep all Confidential Information confidential and will not, without the Disclosing Confidential Information consent, directly or indirectly communicate or disclose Party's prior written consent, directly or indirectly communicate or disclose (whether in writing or orally or any other manner) Confidential Information (whether in writing or orally or any other manner) the terms of this Agreement.

- C. Neither party may assign the benefit of this Agreement or any interest hereunder except with the prior written consent of the other.
- d. This Agreement may only be modified by a written agreement duly signed by persons authorized on behalf of each party.
- e. By visiting, registering, and using the services of ALS, or accepting this Agreement MAC understands that the Information or advice provided by professionals shall be used merely as a guide rather than a definitive recommendation to adopt any specific action or treatment. Nothing transmitted to or from zyego constitutes the establishment of a doctorpatient relationship between the members of MAC (staff and students) and any professional providing information or advice through zyego. zyego is not intended to diagnose or provide advise on a medical condition.
- f. MAC and zyego shall publicize this partnership at the college premises, via posters, pamphlets, in classrooms by the faculty, at college events, over social media platforms and on the college website(s).
- g. zyego shall be publishing this partnership with MAC at various forums, website and other platforms
- h. MAC shall display prominently and put up the promotional material of zyego in MAC's premises.

5. Force Majeure

None of the party shall be considered to be in breach of this Agreement to the extent that performance of their respective obligations (excluding payment obligations) is prevented by an Event of Force Majeure that arises after the Effective Date.

The Affected Party prevented from carrying out its obligations hereunder shall give notice to the other Party of an Event of Force Majeure upon it being foreseen by, or becoming known to, the Affected Party.

If and to the extent that the Affected Party is prevented from executing its respective obligations by the Event of Force Majeure, the Affected Party shall be relieved of its obligations to provide the Services but shall to continue to perform its other obligations under the Agreement so far as reasonably practicable and can be executed without depending on the affected obligation.

6. Date of Effect

This AGREEMENT will come into effect on the date of signature and will remain in force for 12 months until either side delivers a written notification to the other of its intention to terminate the Agreement in which case, the present agreement shall terminate two months after the receipt of such a notification. The agreement can be renewed on expiry on mutually agreed terms and conditions.

<u>Termination</u>

ALS and MAC agree that this Agreement may be terminated by either party giving the other a minimum of two months notice in writing. MAC agrees that it will settle all the bills of ALS that have been approved and accepted by them.
